Upcoming amendments to the deposit insurance offered through the Deposit Insurance Corporation of Ontario (DICO) will increase your deposit insurance from \$100,000 to \$250,000 on eligible deposits [January 1, 2018].

EVERLINK (DEBIT CARDS)

The company currently providing and servicing our member/debit cards has submitted a Notice of Termination effective July 31, 2018.

To ensure a smooth transition OCCU has partnered with Everlink for replacement cards. You will receive a new card in the mail already programmed with your existing PIN.

Simply destroy your old card either by shredding it or bringing it to our office. This process is anticipated to begin in March, 2018.
